NEW ITEMS:

- 1: Mailboxes: Erin will send letter out to the homeowners that are not compliant. The letter is to remind the homeowners of the deed restrictions.

- 4: Pond obtrusion: HHHA board does not have jurisdiction over the ponds, per section 4.4 of the declaration of restrictions. A letter will be sent to individual that inquired with a copy of the restrictions.

FINANCIAL:

- 1. Treasures report: Revenues are up by couple hundred dollars, the expenses are up by \$2000.00.
- Doug S. will get the total interest income by the next meeting. Lighting repair needs to go against the capital account out of the operating account.
- 2: The Waterford C.D. has been renewed. \$50,000 has been moved from the PNC checking to a Morgan Stanley C.D.
- 3: Contracts: A; Lawn Care contract has been signed.
- 4: Homeowners fees: Cara has been informed to adjust the fee for the 2nd half of 2023.
- 5: Capital One account: There are 2 names on the account, Jeff Turner and a second that is not clarified. Tom will continue to follow up on this with our accountant.

INFRASTRUCTURE:

- 1: Roadway sealing: Erin will get a date. Homeowners will be informed when this is scheduled.
- 2: Cleanup of roadways: Tom will follow up on this.
- 3: Sprinkler system damage: Crestline (the sanitary sewer Contractor) will take care of the repair expense.
- 4: Planting replacement: Lucas County will reimburse up to \$7499.00 Doug S. will look into the ownership of the land where the plantings will be placed. Tom will continue conversation with Linda and Rick on the plantings.
