New Items:

- 1: Tom received a call from Morgan Stanley and there needs to be a clarification on our official name. Under the state it is to be Hidden Harbour Association Inc.
- 2: Lights on N. Shoreline, Motion was made by Tom not to exceed \$7500 to repair the lights on N. Shoreline. Jerry 2nd. Motion passed. This falls under a capital expense item.
- 3: Clarification on neighbors "Review and Comment". The ACC has the final say but the neighbors will have 2 weeks to give any comments. There should be clarification on the website.

FINANCIAL:

- 1. Treasures report: Budget is on track. With 1% above budget. 87% we are at expense of what budgeted. Doug S. will start working on the 2023 budget.
- 2. Investment of IR fees: 4.35% is what we will be getting with our new Morgan Stanely CD account.
- 3. Contracts: A: Renewed snow removal contract with Countryside: 2-year contract (2 seasons.) With a 2-year contract we will receive a 10% discount.
- B: Renewed our solid waste contract with Republic Services. This will be a 2-year contract. There will be a 12% increase in the 2nd year. (Increase starts October 2023)
- 4. Discuss homeowner fees for 2023: Tabled until the next board meeting in April of 2023.
- 5. Received an invoice for legal opinion for property on E. Shoreline.

- 1. Roadway sealing: Will take place in 2023
- 2: Cleanup of roadways will be looked into a future time with the township.
