1. Approval of Minutes

2. New Business

- **Water Level/Riser Management:** Due to recent rains, the water level is currently at 11 inches.
- **Baja Leveling:** The board decided to have the Baja beach leveled before Memorial Day weekend.
- **Goose Management:** Three goose nests were identified in April. Residents are advised to look for nests near the water and inland up to 50 feet. Please report any sightings to Pat Nowak. The board has hired Buckeye Wildlife to remove the nests.
- **Annual Meeting:** The HHLA annual meeting will be held on May 28th at 7P at the Springfield Township Hall. The board is seeking one new member to replace Jan Siotkowski, Treasurer. Also, Paul Irving, President, is up for re-election.
- **Website and Communication:** The board complimented M. Bruhl for website improvements. Upcoming changes include adding current financial information and resolving technical issues. Residents are encouraged to suggest additional website content to M. Bruhl. P. Irving noted issues with mass emails and the need for a custom domain due to new Gmail and Yahoo regulations. M. Bruhl to investigate adding a custom domain through our current web hosting provider.
- **Minnows:** A request for adding minnows to the lake was received. While the board will consider this, the current priority is goose management and lake maintenance costs.
